

What is the minimum price for imports of solar cells?

Under the government's new calculation method, the minimum price for imports of solar cells will be \$60/kg. Hakki Karacaoglan, the CEO of Germany-based consultancy KRC Energy, said that the new rules could drive down the market share of imported cells in the Turkish PV market, as they favor local manufacturers.

Does Turkey have a minimum import price for solar cells?

The Turkish government has set a minimum import price of \$60/kg, so solar cell imports exceeding this threshold will be subject to import duties. The measure is designed to protect domestic cell manufacturers. A 4.2 MW rooftop PV system installed by IBC Solar in Turkey.

What happens if Turkish solar modules import over \$60/kg?
