Does China Import EVs from the EU?

EU imports of EVs from China are surging, but still represent a small share of EU car sales. Most imports from China originate from joint ventures of EU and Chinese manufacturers, and from Tesla, which is the largest importer. In the meantime, China is starting its own investigation into some EU exports, such as cognac 2.

When will the EU levy a new battery electric vehicle?

The duties are subject to approval by EU countries, expected in November. The vehicles affected are new battery electric vehicles designed for the transport of nine or fewer persons.

Which reference is used to calculate a battery subsidy?
