

What are compensatory damages?

Compensatory damages may be contrasted with damages which are not strictly compensatory because, for example, the claimant may have suffered damage but cannot prove actual loss or they have suffered no loss but the breach of contract or duty results in a benefit to the wrongdoer.

Why is the tort of battery limited?

The tort of battery has also been limited in the protection it affords due to the emphasis on the need to find a deliberately inflicted harm upon a patient, which occurs rarely in cases of medical practice. See how another researcher answered the same question

Can a tort of negligence and battery be regarded as authoritative?

Is battery a criminal charge in a medical case?

The lack of judicial support for the use of battery in medical cases flows from the assumption that battery involves deliberately inflicted injury.²¹ Since a battery may also give rise to a criminal charge of assault, judges have been reluctant to criminalise by association, misguided decisions to withhold information from patients.²²

Does the tort of battery protect patients' right to autonomy?

Legal scholars have observed the narrow application of the tort of battery by the courts and it has been suggested that a broader application of the tort of battery may better protect patients' right to autonomy.

Can the tort of battery be used without patients consent?

The tort of battery has been used successfully in cases where treatment is given without patients consent.
