How to register a business in Fiji?

You are now ready to register your business with the Registrar of Companies. You will need to prepare your ownership details and determine the area of business that you will primarily be engaged in. Register for Tax Identification Number (TIN) Proceed to the Fiji Revenue and Customs Services (FRCS) to register for a Tax Identification Number (TIN).

Do I need an agent to set up a business in Fiji?

The investor will now register directly with the Registrar of Companies however, Investment Fiji will provide facilitation assistance to register the projects. 2) Do I need an agent to help me set up my business? It is not mandatory for investors to engage agents to set up a business in Fiji.
