At the moment, the U.S. does not require importers to have a license specific to battery imports. Most lithium battery regulation has to do with the shipping process.

Can You import lithium batteries by air?

Aside from IATA, you also need to look at the International Civil Aviation Organization (ICAO). They're a closely related group and tend to use the same DGR. Importing lithium batteries by air also means you need to confirm a specific UN classification number for your products. There are six UN classification codes for lithium batteries:
