What is Eve's Malaysia factory project?

EVE's Malaysia factory project consists of two phases. The first phase is the "International Cylindrical Battery Industry Park" project, with an investment of no more than 422.3 million US dollars, located in Julin County, Kedah, Malaysia. Construction officially began on August 7, 2023; The second phase is an energy storage project.

When will Eve energy start production in Malaysia?

Vincent Wong, Senior Vice President of EVE Energy, explained on-site that the Malaysia plant, having commenced construction in August 2023, has achieved a remarkable milestone by completing its construction in just 16 months. With equipment now being installed, the plant is expected to commence production in the first quarter of next year.

EVE Energy co-founder and CEO Liu Jianhua said "the construction of EVE Energy's Malaysian factory will further promote cooperation and exchange between China and Malaysia in the field of new energy," he said.
