What is the warranty length for a new battery?

The warranty for this battery consists of 18 months free replacement. Note: 825 Cold cranking Amps and 130 reserve minutes. Warranty consists of 2 years free replacement for the Yellow Top (Deep Cycle) battery. Height adapter may be required, check hood clearance. Battery is vented to the outside of the vehicle.

Does recalibrating a GE battery fix a battery problem?

Of course, we have raised this issue with GE (GivEnergy), and initially, they told us that recalibrating the battery would fix the problem. Recalibrating simply means discharging the battery to 0% and then charging it to 100% so the software can learn the bottom and top values.

How much battery charge is lost a day?

That's approximately 3.4kWh gone up in the air,which is 34% of the battery. And this is happening a couple of times a week. I ran a couple of tests, and it appears that 1kWhof battery charge is lost per day! Of course, we have raised this issue with GE (GivEnergy), and initially, they told us that recalibrating the battery would fix the problem.

What does recalibrating a battery mean?

Recalibrating simply means discharging the battery to 0% and then charging it to 100% so the software can learn the bottom and top values. However, as they are unable to schedule the recalibration (i.e. so it happens at night when energy is cheaper), we were postponing it.

It also sounds like you"re not even at the battery capacity warranty trigger point yet (less than 9 battery bars of 12 remaining). Your issue seems to be that the "guess-o-meter" is freaking you out. The behavior you describe is very normal and reflects the huge difference in energy consumption for driving on the highway versus in town.

Nissan LEAFs do have a degradation warranty where Nissan will replace the HV battery if it drops to 8 of 12 bars during the warranty period BUT on 2015s and older (as well as 2016 S trim with 24kWh battery), that warranty is only for 5 years / 60k miles so is no longer valid on your car (the 2016s with 30 kWh battery as wells as 2017s and newer have an 8 year / 100k miles ...
