Will Sweden introduce a new capacity market mechanism in 2028-2029?

The Swedish government plans to introduce a new capacity market mechanism in 2028-2029to support the further development of the energy storage market. The Swiss energy storage market is expected to grow from 318 MW in 2023 to 1.3 GW in 2030.

Will Ireland's battery storage capacity grow in 2023?

Ireland's battery storage capacity is expected to grow from 792 MWin 2023 to 3.9 GW in 2030, mainly in the pre-table storage market. In the early 2020s, Irish energy storage projects were off to a rapid start, but the market slowed from 2023 to 2024.

What is Italy's energy storage capacity in 2023?

Italy's installed energy storage capacity in 2023 is 3.9 GW, and is expected to increase to 18 GW by 2030, mainly in the pre-table energy storage and household storage markets.

Are grid-side energy storage projects a good idea in Belgium?

Grid-side energy storage projects in Belgium have good prospects, thanks to low grid charges, no double charging policies, and diversified revenue sources. In 2023,11 new battery projects in Belgium have been awarded capacity market contracts, totaling more than 363 MW.

What is the future of energy storage in Finland?

The Finnish energy storage market is expected to grow from 185 MW in 2023 to 1 GW in 2030, mainly focused on grid-side storage. With the growth of wind power capacity, especially offshore wind power, the demand for large-scale energy storage systems on the grid will increase.

In the United States, developers installed 8.7 GWs of battery storage capacity in 2023, a 90% increase from the prior year. The global storage market grew by 110 GWhs of energy storage capacity in 2023, an increase of 149% from the previous year. Investment in the global storage sector grew 76% in 2023, to \$36 billion.
