The UK should follow suit and adjust upwards its EV import tariffs, while agreeing a European battery alliance with the EU for a tariff-free EV supply chain. Tariffs will not stop Chinese companies from building factories in ...

The tariff rate on lithium-ion batteries for other items is expected to match this rise in 2026. If Donald Trump wins this November's election, tariffs could climb even higher. As tariffs surge, American companies that import lithium-ion batteries from China must urgently reassess their supply chains.

On May 14, the U.S. side released the results of the four-year review of the 301 tariff increase on China, announcing that on the basis of the original 301 tariffs on China, it would further increase the tariffs on imports of electric vehicles, lithium batteries, photovoltaic cells, critical minerals, semiconductors, steel and aluminum, port cranes and personal protective ...

In 2023, the average Chinese battery EV imported into the EU was valued at just over EUR25,200 - 32 per cent lower than the price of non-EU imports (EUR37,130) and 16 per cent below the average price of battery EV ...

Some of the steep U.S. tariff increases on an array of Chinese imports, including electric vehicles and their

batteries, computer chips and medical products, will take effect on Aug. 1, the U.S ...

EV applications from 7.5% to 25%, effective in 2026. As there is also a 3.4% general tariff on lithium-ion battery imports, the full tariff paid by importers will go from 10.9% to 28.4%. Lithium-ion battery modules, packs, and container blocks are generally categorized under the import code 8507.6020 if they are used for non-EV applications.

The American Clean Power Association (ACP) has approved the Biden Administration's decision to impose Section 301 tariffs on lithium-ion batteries imported into the US from China, doubling the tariff rate to 50%. The ...
