What happened to a lead acid battery plant in the United Arab Emirates?

March 24,2022: Ground has been brokenfor a combined lead acid battery manufacturing plant and recycling facility in the United Arab Emirates (UAE),Italian group Seri Industrial announced on March 22.

What is Royal Gulf doing with lead batteries?

According to Royal Gulf, the facility will be recyclingnearly 60% of the lead battery scrap generated annually in the UAE. The company said it planned to invest a further AED125 million in the site, during a three-year second phase, to make the UAE "a hub for recycling metals and creating global supply chains".

Is dubatt the UAE's first battery recycling venture?

Royal Gulfhas described the project as the UAE's first battery recycling venture. However, BESB reported in March that Dubatt Battery Recycling had broken ground for a combined lead battery manufacturing plant and recycling facility at Dubai Industrial City, in which it is investing AED110 million.

Is this UAE's first battery recycling project?

He said the project had been three years in the planning including obtaining various regulatory approvals. Royal Gulfhas described the project as the UAE's first battery recycling venture.

What are the federal regulations relating to used or spent lead acid batteries?

The 3 main Federal Regulations that relate to the safe management of used or spent lead acid batteries, are; The Environmental Protection Agency's (EPA) Hazardous Waste Regulations, regulated under Subtitle C of the Resources Conservation and Recovery Act (RCRA).

How much will Royal Gulf invest in a lead battery recycling centre?

August 11,2022: Royal Gulf Industries said on August 4 it would invest more than AED62 million (\$17 million)to build a lead batteries recycling centre in the United Arab Emirates.
